The Council received a presentation from representatives of Bayford Parish Council regarding a planning application at Bunkers Quarry. Bayford Parish Council sought agreement from Little Berkhamsted Parish Council that a joint response, signed by both Parish Council Chairman, would be appropriate given the cross border impact of the application.

It was RESOLVED that:

a) The Council shared the concerns of Bayford Parish Council and authorises the Acting Chairman to sign a joint Bayford/Little Berkhamsted Parish Council response to the planning application outlining these concerns.

The Council noted recent decisions from East Herts Council on various planning applications and requested that the practice of displaying planning applications at the meeting be resurrected. 11. HALL, COTTAGE AND OPEN SPACES

It was noted that there were some trees which required attention around the Parish, particularly opposite the Village Hall and that a formal proposal for trees in Goddard's Close was being progressed via Highways.

It was reported that some trees near the Beehive Pub required attention as they were in danger of damaging the BT lines. This has already been reported.

There was also some concern regarding the re-routing of the EDF electrical supply to 31 Church Rd.

12. HIGHWAYS MATTERS

Various Highways issues were discussed and there was an inquiry with regards to available funds for traffic calming measure and it was confirmed that a small amount of money was available but that the Parish Council had limited powers in this area. It was suggested that enquiries in to the Drive Safe scheme could be initiated to see if local residents were prepared to assist in a project to lower speeds through the village but there were concerns around the safety aspects.

The Council expressed its thanks to John Devine for pursuing the Highways to ensure that work on Robins Nest Hill was finally completed.
